19B15/19B16 Line Upgrade Project

Proposed replacement of transmission line towers in the Riverfront Area, Bordering Land Subject to Flooding, and the Floodplain. Project is located perpendicular to Hockanum Rd, near to the cemetery. Melissa Kaplan from BSC Group presented on this project, first giving an overview of the old vs new towers, the nuances of the site, and answering the commissioner's questions. Due to the presence of rare species habitat on-site, NHESP must conduct a review, and since this review had not been completed, no decision could be made at this time. A file number had been issued, so DEP's comments were addressed.

Howard Johnson Redevelopment Project

Proposed demolition of the existing Howard Johnson hotel building, and constructing a 3-story office building on the same site, which is in both the 100-foot buffer zone and the town bylaw 35-foot no disturb zone. Michael Gagnon provided a history of the site and explanation of proposed plans, walking the commissioners through the plan sheets and answering questions along the way. This project will be subject to peer review per the planning board, and the Conservation Commission would also like a peer review to be conducted, which Shyla will work on coordinating. Additionally, no comments or file number had been issued so no vote could be made regardless.

The commissioners could not formally vote, seeing as there is no project, but they took a straw vote to provide insight into how the board felt about this idea.

Chris Bloom would like to receive input from the Commission regarding his hopes to remove the slaughterhouse on Shattuck road and put in ANR lots. There is a potential restriction due to NHESP mapping and alleged spadefoot toad presence. Chris will be supplying the Commission with his documents for several years of biological studies to aid in their advising whether it might be possible permitting-wise.
