#### Note:

The agenda was re-ordered for discussion due to a need to close the existing OOC for 170-0277 being improperly placed after the hearing for 170-0284. Additionally, staff was excused to retrieve signature documents which necessitated the re-arrangement/pause of items until she returned with the paperwork.

## **Request for Determination – 85 Russell St**

After a project description by Don Dion of the project goals and all questions being addressed there was a motion made by Gordon to issue a negative determination of applicability, #2, to Don Dion for the removal of an existing garage. This motion was seconded by Edwin, and all members voted in favor.

#### Invalid Certificate of Compliance for DEP File #170-0277

In order to move forward with the file #170-0284, headwall replacement on Knightly Rd, the previous Order of Conditions needed to be finalized via issuing a Certificate of Compliance, as required by the state DEP's dual notice policy. There was a motion made by Edwin to issue an invalid Certificate of Compliance – invalid seeing as no work was initiated or completed for that project. This motion was seconded by Gordon, and all members voted in favor.

## Notice of Intent Public Hearing – DEP File #170-0284

After much discussion and review of the most recent plans, and all questions answered by the applicant and project representative, and with comments from DEP addressed, a motion was made by Steve to approve this project with the standard Orders of Conditions from the state and the same Special Conditions as applied to the previous project (file #170-0277) with the exception of the time of year restriction. This was seconded by Gordon, and all members voted in favor.

# **APR Funding**

After discussion with Mary Thayer of the CPA, and deliberation, Gordon made a motion to allocate \$33,000 from the Conservation TDR account to fund the acquisition of the proposed 57-acre APR owned by Arthur West. Ray seconded this motion, and all voted in favor.
