What is Stormwater Runoff?

Stormwater runoff is rain or snowmelt

that flows over the ground. As it flows over driveways, streets, lawns and sidewalks, it picks up debris, chemicals, dirt, and other

pollutants. Storm water flows into drainage ditches or catch basins which are part of Hadley's storm water system. Stormwater runoff is discharged untreated directly into lakes, streams, rivers and wetlands.

What types of debris can cause pollution?

- Yard trash like pet waste and grass clippings;
- Fluids that leak from cars and trucks, like oil, gas, and antifreeze;
- Litter of all kinds including waste paper, bottles and cans;
- Fertilizers and pesticides; and
- Sand, salt, and soil from roads, unpaved driveways, or construction sites.

Pollution is not only caused by industry .

In recent years, sources of water pollution like industrial wastes from factories have been greatly reduced. Now, more than 60 percent of water pollution comes from things like cars leaking oil, fertilizers from farms and gardens, and failing septic tanks. All these sources add up to a big pollution problem.



Why do we need Clean Water?

Having clean water is of primary importance to our health and economy. The water that we use for swimming, fishing, recreation or drinking can be harmed by the polluted storm water runoff. Hazardous wastes in lakes and streams will poison fish and humans. Trash washed into these lakes and streams can choke birds and small animals.
