Committee Reports: Assignment Updates

J. Maksimoski reported that the Planning Board is working on food truck and entertainment bylaws and asked what issues there are and why is this being discussed, what is the driving force behind this.

M. Spanknebel explained fire regulation including new Fire Regulations which adopted NFPA 1-2021 edition in December. Also reviewed the food truck and LP tank inspection policy that was approved by the Select Board. M Spanknebel provided documents to J. Maksimoski for review and information.

Group also discussed need to do permits for events on private property which property is being rented out or for multiple events including farm stores. Also need to add tag sale policy to the bylaw book. J. Maksimoski recommended that if you exceed 4 events or agricultural events you must first come in front of the Planning Board and must provide for meals tax.

The group discussed the need to update fencing section just to reflect line of site. T. Neyhart recommends keeping this portion only in Article 7. T. Quinlan will review.

The group discussed the need to permit and inspect camp sites for RV's. At a minimum should comply with Fire Regulation 527CMR 1.00 and referenced NFPA 1 and with Massachusetts Amendments.

M. Kuc reported that the new Animal Control Officer for Hadley has sent draft revisions and will be at the March meeting to review with the committee at 9:30.

Group would like to have Ben from BOH at March meeting at 10:30 for food inspections and bathrooms.

T. Neyhart reported on Stretch Energy Code feels that it is satisfied by Building Code and believes that the Bylaw is satisfied as of the date of adoption with most current version of the Massachusetts State Stretch Energy Code.

M. Spanknebel discussed new fee schedule and is working with Jess on updating Certificate of Registrations.

A. Fyden will be discussing revolving accounts after she meets with department heads and committee chairs
