6.4 Transitions of Personnel

The Select Board will discuss recruiting a Building Inspector to take effect no later than April 16, 2020. Mr. Neyhart has offered to assist with any transition.

The Select Board will discuss recruiting a Town Administrator to take effect no later than December 31, 2020. Mr. Nixon has offered to assist with any transition. Recommended that the Town conduct an internal review and then an external review. New candidate will be hired July



1, 2020 and will serve as the chief administrative officer. Mr. Nixon will perform supporting work. A professional recruiting firm will be explored.

Christian Stanley announces Tim Neyhart's retirement and states that we need a suitable replacement.

Tim Neyhart presented options for Building Inspector.

Edward O'Connor asks what is most beneficial to the Town of Hadley.

Joyce Chunglo she wants Hadley to be the prominent town in any sharing possibility not joining in with Northampton or Amherst.

Tim Neyhart states we have to have a local inspector and you could go out and see what is there. Molly Keegan states a hiring committee needs to be formed and HR needs to be involved and continue with parallel path.

Michael Spanknebel states he wants to make sure we include Tim Neyhart in the hiring committee and that the good relationship with the Fire Department is continued.

Ed O'Connor states he needs to meet with Tim Neyhart and we must have a building commissioner.

The committee will be finalized when the job description is ready.

David Nixon states that his contract for Town Administrator has been extended until December 31, 2020. We should have an internal review and then it should go out for external with hope of hiring by July 1, 2020. David Nixon and new Town Administrator will have a 6 month overlap. Christian Stanley thanks David for his service to the town.

Molly Keegan asks that we offer quickly internally and then move on. She further states that she would like the internal review to be done by January 31st and would like to work with outside professional service. We might also want to make sure that we have a person who could be a town manager as well.

6.5 Public Safety Complex Emergency Generator and Other Capital Not Funded

Christian Stanley states that the generator failed by 1 vote. We don't have enough free cash at this time.

Michael Spanknebel states that the generator failed the night before the vote. We met with the generator representative and the current generator is back online. We also met with FM generator responsible provider and they recommended a smaller generator. The current generator is outdated and we need a new smaller one. The recommendation is Blue Star which is made in Wisconsin.

We also have to decide how to power the generator. We are discussing switching to a diesel powered generator that switches over to natural gas backup.



David Nixon offers recommendations thinks borrowing within the levy is the best choice. The Select Board doesn't agree to this.

Joyce Chunglo states that we should sell the French ST. [property.

David Nixon says we can't use free cash, since we do not have certified free cash. We will meet with the Treasurer to see if we can fast track French St., we will also speak to bond counsel and to Representative Carey.

7.1 Community Development Block Grant Preparation

The Select Board is asked to designate the Town Administrator as the Environmental Certifying Officer for the Community Development Block Grant application. If the Town's application can be previewed by the participating Federal agencies that monitor environmental issues, then the Town's application can receive more points -- thereby increasing the likelihood of funding. The Environmental Certifying Office works with all Town regulatory agencies (e.g., Conservation Commission, Planning Board, Historic Commission, and others) to make sure that specific housing rehabilitation projects comply with all local and state environmental requirements. Motion to designate David Nixon as Environmental Certifying Officer.
