The Alternative Management Plan will be developed in coordination with the Pioneer Valley Mosquito Control District (PVMCD). https://www.mass.gov/info-details/pioneer-valley-mosquito-control-district-pvmcd, with input from Town of Hadley residents and the recommendations of the Hadley Board of Health.

Active data from the MA Mosquito Control for the Twenty-First Century Task Force, which is charged with producing urgently needed legislation to overhaul the way our Commonwealth does this work, will
