Review-

PaintCare- from Tom Irwin- “A lot has happened since I had the pleasure of meeting with you and your group. You’ll be pleased to know that Senator Comerford has signed on as a cosponsor. Several representatives (12) and (4) senators have become cosponsors of the Bill, which although modest is more support than the Bill has during the last session and it’s still quite early!. So far (3) newspapers in western Massachusetts have carried articles about the Bill and (4) and growing letters to the editor about the Bill have been published in eastern Massachusetts papers with letters to the editor soon to appear in western Massachusetts papers as well, which has resulted in increased “buzz” in the State House about the Bill. The first of 7 planned public forums across the state will occur in Pittsfield on July 12th (see attached) with the second occurring on or about August 23rd in Amherst at either UMass or Hampshire College with the goal of further increasing public awareness. These forums will feature national experts on paint and mattress recycling, a paint bill sponsor and the chair of the Massachusetts Product Stewardship Council. Hopefully, you and other interested members of your committee will be able to attend the Amherst forum! I think you will enjoy it. So, it’s all good and I think that we are truly moving forward toward our goal.”
