TOWN OF HADLEY, MASSACHUSETTS SELECT BOARD CONSENT AGENDA

Items on a Consent Agenda are exceptions to the general process of the Select Board's Meeting. The Select Board identifies those business items that they believe should generate no controversy and can be properly voted without debate. These items are put on the Consent Agenda to allow motions under these items to be acted upon as one unit and to be passed without debate.

At the call of the Consent Agenda, the Chair of the Select Board will read out the business items, one by one. If one or more Select Board members object to any particular item being included in the Consent Agenda, they say "hold" in a loud voice when the item is called. The item will be removed automatically from the Consent Agenda and voted separately under the usual manner. After the calling of the individual items in the Consent Agenda, the Chair will ask for a motion that the Select Board pass all items remaining <u>AS A UNIT</u> on one vote. Use of the Consent Agenda process makes the Select Board Meeting more efficient by speeding up the handling of non-controversial items.

The Select Board will discuss the proposed request for special legislation to add off-premise liquor licenses above the state-mandated quota. This matter is currently on the warrant for the Annual Town Meeting. Members of the business community have raised concerns about adding more package store-type licenses.

The text of the warrant article is:

Article 15 (Special Act of Legislation – Off-Premise Liquor Licenses Above Quota)

To see if the Town will vote to authorize the Select Board to petition the General Court for special legislation granting additional liquor licenses in the form set below, provided that the General Court may make clerical or editorial changes of form only to the bill unless the Select Board approve amendments to the bill before enactment by the

General Court, and further that the Select Board is hereby authorized to approve amendments which shall be within the scope of the general public objectives of this petition, or take any action relative thereto.

AN ACT AUTHORIZING THE TOWN OF HADLEY TO GRANT ADDITIONAL LICENSES FOR THE SALE OF WINES AND MALT BEVERAGES AND ALL ALCOHOLIC BEVERAGES NOT TO BE DRUNK ON THE PREMISES

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 1. Notwithstanding section 17 of chapter 138 of the General Laws, the licensing authority of the town of Hadley may grant 5 additional licenses for the sale of wines and malt beverages not to be drunk on the premises under section 15 of said chapter 138 and further the licensing authority of the town of Hadley may grant 5 additional licenses for the sale of all-alcoholic beverages not to be drunk on the premises under section 15 of said chapter 138 to businesses located in business district and the industrial district in the vicinity of Russell Street (Route 9). The licenses shall be subject to all of said chapter 138 except said section 17.

The licensing authority shall not approve the transfer of a license granted pursuant to this section to any other location, but it may grant a license to a new applicant at the same location if the applicant files with the licensing authority a letter from the department of revenue and a letter from the department of unemployment assistance indicating that the license is in good standing with those departments and that all applicable taxes, fees and contributions have been paid.

If a license granted pursuant to this section is cancelled, revoked or no longer in use at the location of original issuance, it shall be returned physically, with all of the legal rights, privileges and restrictions pertaining thereto, to the licensing authority and the licensing authority may then grant a license to a new applicant at the same location under the same conditions as specified in this act.

SECTION 2. The town of Hadley shall charge a fee for the granting of a license authorized in section 1 which shall be paid by the licensee at the time of issuance.

SECTION 3. This act shall take effect upon its passage.



Subject: Bus stop inquiry

Dear Mr. Okafor,

There has been a request from UMass Transit to add a bus stop in Hadley near the intersection of Bay Road and Route 47:



The 39 bus route is the red line. There is a customer who lives on Route 47 south of that intersection, and so he is frequently asking to be let out so that he can get to his house. Our policies prohibit boarding or alighting passengers in areas outside of marked stops, and so this has presented a problem for us. We don't have any objection, however, to installing a pole and bus stop sign near this intersection to accommodate the passenger.

I've cc'ed the Glenn Barrington, the head of UMass Transit, to add to or correct any of the information above. It would be great to chat sometime about adding a stop that the Town and PVTA find mutually agreeable.
