# TOWN OF HADLEY, MASSACHUSETTS SELECT BOARD CONSENT AGENDA

Items on a Consent Agenda are exceptions to the general process of the Select Board's Meeting. The Select Board identifies those business items that they believe should

generate no controversy and can be properly voted without debate. These items are put on the Consent Agenda to allow motions under these items to be acted upon as one unit and to be passed without debate.

At the call of the Consent Agenda, the Chair of the Select Board will read out the business items, one by one. If one or more Select Board members object to any particular item being included in the Consent Agenda, they say "hold" in a loud voice when the item is called. The item will be removed automatically from the Consent Agenda and voted separately under the usual manner. After the calling of the individual items in the Consent Agenda, the Chair will ask for a motion that the Select Board pass all items remaining AS A UNIT on one vote. Use of the Consent Agenda process makes the Select Board Meeting more efficient by speeding up the handling of noncontroversial items.

The Hadley Police Department and the Hadley School Transportation Department are raising concerns about parking near the West St./ Route 9 intersection and the ability to service a bus stop for a new student on the route.

"This afternoon I received a call from Trish Hopf from the school department. She has a concern over being able to service a bus stop on West Street for a kindergarten student that is new to the route. That concern is as a result of overflow parking from Esselon Café on to West Street.

In reviewing our by-laws, we already have the ability to cite vehicles that park within 20 feet of the intersection, but I think it might be beneficial for that area to restrict the parking on West Street even further and post signs. I also think that posting signs and trying to prevent the behavior will work better than going and writing parking tickets. Maybe the addition of "No Parking here to Corner" for the northbound side and "No Parking Between Signs" for the southbound side?"
